ANNUAL MEETING OF PARISHIONERS

Election of Churchwardens: Lizzie thanked the churchwardens, Karen Ball and Mike Heylin for their immense support and hard work throughout the year and gave them a gift in appreciation. She thanked the deputy wardens, Kathy Perry and Beverley Burgess for their commitment. Terry Perry, proposed by Karen Ball, seconded by John Walker and Beverley Burgess proposed by Linda Cooke, seconded by Terry Perry were duly elected as churchwardens, with thanks. **All Agreed**

The Annual Meeting of Parishioners closed at 11.40 am.

ANNUAL PAROCHIAL CHURCH MEETING

- 1. Minutes of the APCM held on 24 April 2023 were approved and signed as a true record.
- 2. **Matters Arising** There were no matters arising.
- 3.1 **Electoral Roll Report –** It was noted that there is a strong membership at HT. The ER in 2023 was 147 and in 2024 the roll stood at 151 as there had been 2 deaths and 6 new people had joined the ER. There will be a New ER in 2025, with the criteria being that anyone living in the parish is eligible or anyone living outside the parish but is a regular attender is eligible. Lizzie extended thanks to Norah Tattersall for her work on the Electoral Roll.
- 3.2 Report on the proceedings of the Parochial Church Council (PCC) including Safeguarding and Parish Activities Safeguarding is dealt with by Pauline Lyndsey. As there were no questions for PL, Lizzie sincerely thanked her for her hard work. Beverley Burgess' report on the Social Committee missed the bundle and can be viewed on the noticeboard in the Trinity Room. Lizzie thanked Beverley and her team for their excellent work. Lizzie thanked Sue Gouch for her work as PCC secretary.

We are grateful to Terry, Mike and Miles for streaming our services.

We need to thank the members of the PCC for their sound governance of the church, and we are indebted to all the volunteers who willingly give their time and effort to help with the running of the church. Without their contribution, the church would not function.

The written reports were noted.

3.3 **The Financial Statement of the Church and to Approve the Accounts -** Martin Chapman gave everyone a big thank you for their contributions to Church running costs of £3326 and all those who do work fundraising. This money is put towards heating costs. Thank you to those who gift aid their contributions. Thanks also go to Kathy Perry and Sue Gouch for counting and banking the money. Martin thanked Geoffrey Dix for inspecting the accounts.

Martin Chapman proposed the accounts which were seconded by Dick Selby. All in favour.

Lizzie expressed huge thanks to Martin for managing the accounts throughout the year.

3.4 **Fabric, Goods and Ornaments of the Church –** This was covered in the report. Mike Heylin thanked Mike Hawtin and others for their support. There was a lot of work to be done in this next Parochial year.

Sam Stanbridge said that she would like to see more people volunteer to help clean the church, especially with the deep cleans during the year.

- 4.3 **To elect Lay Representatives to the Benefice Team Council** Mike Hawtin and Dick Selby both agreed to continue as lay representatives of the Benefice Team Council.
- 5. **To appoint an Independent Examiner for the PCC accounts for the coming year** Martin Chapman said that Geoffrey Dix was willing to do this and was proposed by Martin Chapman and seconded by Karen Ball. All agreed. Lizzie asked Sue so to send a letter of thanks to Geoffrey Dix on behalf of the PCC.

6. To receive a report from the Rector

It's astonishing, when you read through all these reports, to see just how much goes into our communal life and how broad is the range of our activities. As I approach the end of my time here with you, I feel very fortunate indeed to have been called to such a wonderful vibrant parish and to have worked alongside so many committed people. But this is not going to be a farewell speech! I intend to leave only once, and that will be in two weeks' time!

I think we've had a very positive year and continued the journey not just back to 'normal', but to a 'normal plus' with lots of shoots of new growth. We have welcomed a number of new people into our church family, and some of those have been baptised or confirmed. We have enjoyed a rich variety of worship, nurture activities, a lovely parish retreat, and a full programme of social and fundraising events. We have benefitted from the installation of a new heating system which has enhanced our experience in church, with very little disruption to our schedule. And our new shipping container has made storage so much easier and the church building easier to work in. We are in good heart, with a strong leadership team.

But inevitably there will be some element of disruption when I leave, as by the very nature of my role I have a finger in every pie and co-ordinate a lot of what goes on! I have been making a lot of effort to leave things in good shape. The clergy rota is very nearly complete right to the end of the year, and various groups and individuals have already been nominated to pick up a range of tasks that I'd

normally lead on. Some of you may be wondering what happens when a vicar retires. The Bishop and Archdeacon are already actively preparing for the future. They have arranged a meeting for 1st May with the ministry team, wardens and PCC to discuss the way forward. The first task will be to see if we can appoint a Team Rector from within the team, and interviews will be held later in May, If that appointment goes ahead, you will then be looking for a Team Vicar for Holy Trinity, and our PCC will need to get to work on the Parish Profile. If that appointment doesn't go ahead, you will be looking for a Team Rector based at Holy Trinity. The Parish Profile is a hefty document that gives prospective candidates all the information they need before deciding to apply. Information about the area - school. leisure, transport facilities; the vicarage; the nature of our team and the way we operate; the Deanery and its pattern of clergy meetings, the Diocese, training opportunities etc; the support that can be expected; some parish statistics & our accounts; our churchmanship; our pattern of worship; our Mission Action Plan; the spirit of HT; the challenges and opportunities this post will present - how do vou want to develop in the future? What are our weaknesses? You will have to decide where to advertise, and the Bishop will present a timetable for shortlisting and interviews. All being well, a successful candidate would probably need to give three months' notice. So, you may be looking at 9 to 12 months, or so of interregnum.

During that time the wardens are legally in charge of the parish. I'm sure the team you've just elected, and deputy wardens to be appointed at the next PCC meeting, will serve you well. Jos has been very generous in offering to cover 2 Sundays a month at Holy Trinity, as well as baptisms, weddings and the main seasonal services, so your worshipping life will carry on in a similar pattern. But Jos works part-time for the Safeguarding Dept of the Diocese, and she will not be stepping into my shoes as a stand-in vicar, so please be mindful of that. I hope you will benefit from the different styles that visiting priests will bring to your worship and give them a warm welcome. Your wardens and PCC will need support from you all, and willingness to share the load.

Reading over last year's APCM papers I see that I said, 'lay participation is vital to a church community; every member ministry is the very nature of the church, and our calling in baptism. The Vicar is not here to do everything for a passive audience! We are essentially and intrinsically corporate. Literally a body. We are the Body of Christ.'

I would like to share with you a presentation I gave to some of our newer church members last year, which I hope will illustrate the full picture of our parish life. The PowerPoint presentation is attached.

3.2 Report on the proceedings of the PCC including Safeguarding, and parish activities Proceedings of the Parochial Church Council 2024 – 2025

The Parochial Church Council (PCC) is a corporate body established by the Church of England and operates under the Parochial Church Council Powers Measure. It is a charity excepted from registration with the Charity Commission. PCC members are appointed in accordance with the Church Representation Rules. It has the responsibility of co-operating with the Vicar (when appointed), in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. Its membership consists of the Clergy, one Lay Reader, two Church Wardens, three representatives to the Deanery Synod and those elected by the Parish to serve on the PCC for a period of three years. Following the APCM in 2024 it approved the following appointments: Rev'd Jos Perris (Associate Priest). Karen Ball, Tim Bourne, Frances Brown, Beverley Burgess (Churchwarden), Martin Chapman (Treasurer), Liam Derham (Deanery Synod rep), Lorraine Ellis, Colin Gage (Deanery Synod rep), Sue Gouch (Secretary), Mike Hawtin (Team Council Rep), Mike Heylin, Pauline Lindsey (Safeguarding Officer), Mark Millar, Kathy Perry, Terry Perry (Churchwarden), Lesley Ripley, Dick Selby, Sam Stanbridge and John Walker. The following appointments were also approved: Deputy Wardens - Kathy Perry, Mike Heylin and Karen Ball, Health and Safety Officer - Karen Ball and Electoral Roll Officer - Norah Tattersall. All on the Electoral Roll were appointed as Sidespeople. The Standing Committee has power to transact the business of the PCC between its meetings, subject to the overall directions given by the Council. This comprises the Vicar (when appointed), Church Wardens and Deputy Church Wardens, Secretary and Treasurer. The Standing Committee conducts business by email and its work is reported at each PCC meeting by the Secretary.

We have continued to hold PCC meetings every other month in the usual pattern and only one PCC meeting date was changed so that PCC members could watch the European Cup football competition. Whilst the Churchwardens alternated as Chairman of the meetings, few decisions were made while we were without a Vicar. The PCC unanimously Agreed to re-introduce the wine Chalice and Open Church started.

Over and above the PCC Secretarial duties this year, I have been involved with the following workload since the end of April 2024 in assisting the Churchwarden team:

- Weekly editing and production of the Bulletin using Publisher.
- Liaising with the Team Administrator, the churchwarden team, Jos and the presiding and preaching priest to ensure that our bulletin contains the correct Priest/Preacher, Readings, hymns, JC leader and daily activities plus whatever needed to be included in the weekly bulletin.
- Being part of the team that discussed and produced the Profile for the advert for our new vicar.
- Maintaining the Church online Diary (especially logging Baptisms, Weddings and Funerals) as well as events, external Groups. Liaising with the CA group if their dates need changing. Maintaining the bookings for all the Church Groups on an annual basis.
- Setting up the Holy Trinity email to send out 27 email invitations to local people, dignitaries and church members to the Installation and induction of Diana. Preparing a spreadsheet of acceptances/declines so that the churchwardens would know who was coming to the Service on the 24th April. Forwarding the emails to the c/the Beverley and Terrys if people requested further info. I was still forwarding messages until the afternoon of the 24th April, the day of the Installation!
- Preparation of the documents for the 'Bundle' for the APCM. Sending individual Emails to 20+ people requesting their reports for the APCM (and receiving 2 extra reports). Editing the reports and putting them into one document. Downloading the necessary documents for the APCM from the Diocesan website notice of meeting to attach to church door, application forms to be a member of the PCC, Churchwarden documents to complete after the vote at APCM. Preparation of the Agenda for the APCM prior to meeting with Diana.

Safeguarding Report

I have reported at each of the bi-monthly PCC meetings on Disclosure and Barring clearance and the required training of individuals to support this. The PCC has complied with the duty to have 'due regard' to the House of Bishops' Safeguarding Policy and Practice. There have been no reported safeguarding incidents within Holy Trinity since the last APCM. Our Safeguarding policies were reviewed, approved and signed off at our March PCC meeting and updated copies are in all four folders (Vicar, PL, vestry cupboard and the bookcase in the Trinity room for public access). The Diocesan website is updated with DBS certificates and training courses completed.

Reports on Parish Activities: Worship and Spiritual Growth Church Wardens Report

After the 2024 APCM we hit the ground running starting with Lizzie's retirement and the process and preparation of finding a replacement vicar for Holy Trinity. A committee was formed and many meetings held, the parish profile and advertisement were approved by Bishop Jane of Hertford and Archdeacon Charles, AD of St Albans. The dates were decided, we were fortunate to have Diana apply for the vacancy and after a successful interview day, Diana was offered and accepted the position and here we are! Last May we eventually achieved an Open Church, something that had been discussed and planned for quite some time. We have a rota of willing volunteers to open the church at 10am and close up at 4pm, unless there are services taking place. We set up a WhatsApp group with the volunteers, so if anyone is unable to open or close the church on their day, a request can be made for another volunteer to swap or take their place, this system works really well. Most of the larger church valuables are locked in the old vestry after the service has finished on Sundays and brought back out the following Sunday before the service. A secure lock was put in place on the Trinity Room door so that visitors cannot access it or disturb any groups that use this space. We have had many comments in our visitor's book that show visitors appreciate the church being open as a place for quietness and prayer. 2024 also saw Holy Trinity's 175th anniversary, officially the date is in October but we celebrated on Trinity Sunday, when we had the pleasure of having Archdeacon Charles taking our service. The AD stayed for a celebration drink, the BBQ and cake, we also held an anniversary exhibition in church all weekend. We have been incredibly well supported by Jos all year, her dedication and commitment to Holy Trinity during the vacancy has been invaluable and we would like to thank Jos for her unwavering support. We would also like to thank our deputy wardens, Kathy, Karen and Mike, we've been a great team! We would also like to thank the PCC Secretary, Sue Gouch and the PCC for their help and support during the year.

Baptism Report

This year we have had 19 baptisms of both adults and children here at Holy Trinity.

Baptisms services are generally held after our Sunday service or on Sunday afternoons. Church families may choose to make it part of morning worship. Jos has run preparation classes for parents before booking and a member of the team assists her, providing hot drinks and biscuits.

On the day, two people are there to welcome the families and their guests, and act as sidespeople during the service. One of the team will come forward with a taper lit from the Easter candle to light the Baptismal candle which is then given to the child/adult. Once the families have left, the church is then tidied and the register completed.

My thanks as always go to the whole team Ruth Carl, Linda Cooke, Pat Driver, Lorraine Ellis, Sue Gouch and Jean Hunter for ensuring a warm welcome for baptism families at Holy Trinity. Choir Report

The choir has continued to support the congregational singing on Sundays and holy days and has sung an anthem and an introit at each service, except at non-eucharistic family services. The choir sang for the switch on of the village lights in November and at the Carols by Candlelight in church in December and also at the Ecumenical Carol Service at Our Lady Queen of All Creation. They also sang for three funerals of church members and for the funeral of Pat Brown who had been a valued choir member for many years. During the year the choir have sung jointly with the choir of All Saints' Kings Langley at the team services, the installation of the Team Rector, and the Confirmation service. Some choir members also sang in the Fauré Requiem

and at some evensongs at Kings Langley. Currently we are working hard on music for the installation of our new Team Vicar. We are grateful that Matt Tattersall has continued to accompany the service once a month, and that John May (trumpet) has played for special occasions such as Christmas and Easter.

We are very fortunate that a new soprano has joined during the year: Abby Robertson. We now have nine members: four sopranos, two altos, two tenors and one bass. We would welcome new members, especially in the lower parts. It is not necessary to read music, just to be prepared to listen to the other singers and sing in tune.

HOLY TRINITY CHURCH - LEVERSTOCK GREEN Treasurer's Report to APCM - Year ending 31/12/2024

Firstly, a big thank you for the contributions of time and money during 2024 which allow us to continue the work of this Church. We ended the year with a running costs gain of £7,976. This was much better than anticipated due to fundraising efforts and the stewardship campaign. However, costs continue to rise, particularly for heating and maintenance, so that we need to draw on reserves, grants, donations or fundraising to cover all costs.

Our total assets rose to £167,367 (£153,859 in 2023) and our CCLA investments could realise a further £35,000 when we need them. We will need them for:

- Repairs to Trinity Room Heating
- Repairs to car park entrance
- Repairs to walls and windows due to extensive settlement cracks
- Replacement of rotting Trinity Room roof
- Redecoration of Church interior
- Increased insulation to reduce energy costs and to help preserve the environment.
- Increases in Parish Share (£3,909) to pay for Clergy and support from the Diocese

A building of this type will always be expensive to maintain, and we would like to extend the ministry of the Church in Leverstock Green – so we need to increase our reserves! In comparison with 2023:

- Collections and Regular Giving increased by £9,200
- Income from donations was down by £3,800
- Electricity cost £7,331, (2023 was £7,065)
- Our contribution to the Diocese for Clergy & Diocese for Cl
- Clergy expenses were down by £515, as we had no Incumbent for much of the year, but fee
 income was down in consequence (by £2,103) and we spent over £1000 advertising for a new
 Incumbent.

Highlights!

- Even during the interregnum, we have provided varied opportunities for worship, ministry and friendship every week. This was facilitated by our members and Revd Jos Perris, to whom we are very grateful.
- We received small grants from Herts. County Council, Leverstock Green Religious Education Fund, and the Blakemoor Foundation towards our mission.
- Our members contributed £10,502 in fundraising through concerts, quizzes, tea towels, books, cards, etc.
- We held a Christmas Fair which raised £3,151 and received two bequests amounting to £3,000.
- Charities

We contributed to Action Aid, The Children's Society, and Herts. Air Ambulance, Sunnyside Rural Trust, Rennie Grove Hospices, Medecins Sans Frontieres, Leprosy Mission (Bishop's Harvest Appeal) and DENS. We have set aside £5,146 for Charities, 5% of our income, as in previous years. Suggestions for this year's distribution of the 2024 allocation will be most welcome.

The Future - Budget for 2025

Our unavoidable expenditure continues to rise, and our Parish Share and fuel costs will rise considerably, so, we would welcome an increase in income from regular giving and donations from our Members. We would strongly encourage members to join the Parish Giving Scheme, or to consider payment by regular banker's standing order. Anyone who is a taxpayer can Gift Aid their donations by completing a Gift Aid form, available from the Treasurer, to enable us to reclaim tax, which added almost £15,000 to our funds in 2024.

As Treasurer I am in the fortunate position of rarely having to handle cash as paying in and Gift Aid records are all handled by Kathy Perry and Sue Gouch. I would like to thank them for all their hard work. We are most grateful to Geoffrey Dix who has undertaken the task of Independent Examiner.

I report to the Parochial Church Council (PCC) on my examination of the accounts of the Parish of Holy Trinity Leverstock Green for the year ended 31 December 2024.

Respective responsibilities of PCC and examiner

The PCC are responsible for the preparation of the accounts. The PCC consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

Fabric Committee Report for 2024/25

In the last year we have completed or considered the following;

Secondary glazing of the east and west windows to reduce drafts and improve heat retention in both zones. This work is ongoing.

We dealt with the black mould in the north and south corners of the nave. We removed the oil and tank from the old heating system. It remains to drain down the remaining system and remove the boiler and header tank. Repairs to the car park exit zone are in hand as at 12th April. The external paintwork on the Trinity Room has been painted during the year. Trinity Room roof, we have been told that an inspection can only be completed by lifting the felt on the roof. The Committee is concerned that an invasive inspection may start a process which then entails re-felting the whole roof, leading to some serious unbudgeted costs. The committee agreed to not conduct a survey of the roof at this time. We have recently installed new heating in the Trinity Room. We believe we need a small working group to develop our thinking around redeveloping the Trinity Room with a view to our present needs and our likely needs when 2,500 additional homes are built to the east of the village and bring perhaps 10,000 new residents to our doorstep. In2021 the village population was 9,712, so the size of the opportunity is to at least double our congregation and capacity for social events. Milke Hawtin has agreed to rejoin the Fabric Committee when his health has improved.

My thanks to all the members of the committee for their assistance and dedication in the last year.

Annual Report on Diocesan Synod for the APCM 2025

The Diocesan Synod is the democratically elected, decision-making body of the Diocese of St Albans. Its membership comprises some 200 clergy and laity split approximately 50/50 and elections from the Deanery Synods to the Diocesan Synod are held every three years (known as triennium). Hemel Hempstead Deanery is allocated four clergy and three lay member places on the Diocesan Synod. The president of the Synod is the Bishop of St Albans and Hemel Hempstead's lay members include Colin Gage. The Synod meets three times annually, one of which is now held online to reduce the need for travel as part of the Diocese's efforts to move towards its Net Zero Carbon target.

• The Synod's first meeting since our last APCM (which was the final one of its 2021-2024 triennium), took place online on 15th June 2024 and happily was chaired by the Bishop of St Albans following completion of his cancer treatment. The first part of the meeting dealt with financial matters and operational reports from the Diocese's various Boards and committees. The principal aspect of the meeting comprised a wide-ranging consultation as to how the governance of the Diocese could be streamlined, made more diverse and improved by a major reorganisation of the various Boards and committees.

- The first meeting of the 2024 2027 triennium took place on 12th October 2024 at the University of Bedfordshire's campus at Putteridge Bury near Luton. It began with a Eucharist and after agreement of the Diocese's financial budget for 2025 and a number of operational reports there was a detailed discussion on the changes in the governance of the Diocese it was planned to carry out commencing on 1st January 2025.
- The most recent Synod meeting was held on 8th March 2025 at Putteridge Bury and was considerably influenced by the fact that it will be last Synod presided over the Bishop of St Albans prior to his impending retirement. Arrangements were agreed to be put in place to cover the interregnum and for much of the meeting members were invited to indicate what they would like to see in the profile of a new Bishop so that it could be incorporated into the recruitment process. Also covered were the controversial discussions arising in the recent General Synod on independent safeguarding arrangements and the Living in Love and Faith issues.

The most recent Synod concluded with a valedictory speech by Bishop Alan in which he said he was disappointed that he had not achieved more in the 16 years he had headed up the Diocese, but he was reassured by numerous members that his guidance and leadership had been invaluable and that he absolutely had no reason at all for disappointment. All members of the Synod expressed their sincere thanks and wished him a long and happy retirement.

The next Diocesan Synod is scheduled to be held on 14th June 2025 and will take place online.

Report of Deanery Synod proceedings (2024 - 2025)

This report covers the proceedings of the Hemel Hempstead Deanery Synod for the period from March 2024 to February 2025. During the year there were three Deanery Synod meetings, covering a variety of different topics. The key areas of discussion are reported below:

Tuesday 18th June 2024 at The Church of the Resurrection Grove Hill. This meeting started off as an open forum where we welcomed an additional 20 guests from around the Diocese. We had Revd Canon Dr Tim Bull join us where he gave a very interesting talk about "Al and a theological response".

As this was the first synod meeting of the new triennium, there were several changes to the committee. Mike Macey, James McDonald & Austin Janes were elected Diocesan Synod reps. Colin Gage, Job Rombout & Lindsay Kemp were elected as the three Diocesan Synod Laity. Carolyn Andrews became the new Deanery Synod lay chair & Sam Stanbridge became the new Deanery Synod secretary.

Tuesday 22nd October 2024 at St Francis' Church, Peter Bladon reported on deanery expenditure so far this year. He firstly wanted to thank all our parishioners for their generous donations throughout the year. Rev Austin Janes was given a grant by the Deanery to help with the cost of printing a book he had written about St Alban. All profits were distributed between Warners End & Grovehill. We used this meeting as a great way to express one positive thing within each parish & a way to get to know each other a little more. The meeting ended with Compline & Benediction.

Tuesday 11th February 2025 at St John's, Boxmoor, we welcomed Glyn Barker – Finance Director for the Diocese, who gave a very in-depth presentation focussed on the diocese's finances. He explained where our parish share goes, and the income and expenditure of the Diocese. Colin Gage also presented us with a presentation used at Holy Trinity's 2024 APCM. The concept was incomings & expenditure for the year using a bath diagram. We could clearly see & understand monies coming in (bath filling up) & monies going out (bath emptying).
